No. F.W./Election-2020/5948 Whereas the Bye-election of Sarpanch, Gram Panchayat Nissing (Gramin), Block Nissing, Distt. Karnal for which poll shall be held on the 15.12.2020 (Tuesday) as per letter of the State Election Commission, Haryana issued vide No. SEC/4E-II/2020/1400-01 dated 20.11.2020.

And whereas, it has been considered necessary to provide opportunity to the public to exercise their franchise.


Now, therefore, in exercise of the powers conferred by sub-section (2) of section 65 of the Factories Act, 1948 (Central Act 63 of 1948) and all other powers enabling him in this behalf, the Governor of Haryana is pleased to exempt only those workers who are working in the Factories in the State of Haryana and are enrolled as the voters where Bye-Election to Sarpanch, Gram Panchayat Nissing (Gramin), Block Nissing, Distt. Karnal are to be held on 15.12.2020 (Tuesday) from the operations of provisions of sub-section (1) of section 52 of the said Act, for the week commencing from 13.12.2020 and ending on 19.12.2020, subject to the condition that no adult worker who is enrolled as voter in election to Sarpanch, Gram Panchayat Nissing (Gramin), Block Nissing, Distt. Karnal shall be required or allowed to work on 15.12.2020 (Tuesday) in the factories of the state of Haryana.
